I. INTRODUCTION

On November 17, 2006, Starwood Power – Midway, LLC, submitted an Application for Certification for the Starwood Power Peaking Project. The proposed 120-megawatt natural gas-fired simple-cycle power plant will be located in an unincorporated area of western Fresno County.

II. SUMMARY OF HEARING


At a regularly scheduled business meeting on January 3, 2007, the Commission accepted the AFC as complete and appointed a Committee to preside over the Starwood Power Peaking Project Application for Certification proceedings pursuant to Public Resources Code section 25211 and Title 20, California Code of Regulations, section 1204.

III. ORDER

Having been accepted as complete on January 3, 2007, under Public Resources Code section 25522, the Application for Certification for the Starwood Power Peaking Project is deemed filed as of that date. The statutory timeline for a final decision under Public Resources Code section 25540.6 shall begin as of January 3, 2007, the filing date. The Commission hereby appoints Jeffery Byron as Presiding Member and John L. Geesman as Associate Member to serve as a Committee to preside over the Starwood Power – Midway, LLC Application for Certification proceedings.
